## What Are the Invasive Aquatic Plants in Florida?

For a source to better understand Florida's Prohibited Aquatic Plants visit the Website for Florida Department of Environmental Protection, Bureau of Invasive Plant Management (<http://www.dep.state.fl.us/lands/invaspec/index.htm>). The prohibited Aquatic Plants are divided into two classes. Class 1 may under no circumstances be permitted to be in possession, collected, transported, cultivated or imported except as stated in Rule 62C-52.004, F.A.C. Here is the list of the Class 1 prohibited Aquatic Plants which includes those being controlled on Lake Istokpoga:

There are only 3 prohibited aquatic plants listed in Class 2.

[Hygrophila polysperma](#) - *hygro*

[Limnophila sessiliflora](#) - *ambulia*

[Pistia stratiotes](#) - *water lettuce*

With close regulation, these 3 species may be cultured in a nursery and sold out of state. They may not be collected in the wild or imported.

### Criteria for prohibited aquatic plant status:

There are four parts to the criteria used to determine if a species should be considered for the prohibited aquatic plant listing and they are based both on scientific evidence and how the plant responds in the Florida environment. The first part of the identification process looks at how rapidly the plant spreads and decomposes its effect on the dissolved oxygen in the water and how it further impairs the ecosystem's ability to function. Next, the species is graded on its propensity to disrupt wetlands in other areas or other countries with climates similar to Florida. Third, the plants

“ability to create dense, monospecific stands or monotypic stands which displace or destroy native plant habitat, destroy fish and wildlife habitats, inhibit water circulation, hinder navigation and irrigation, or severely restrict the recreational use of waterways.” And fourth, the ability to “resist effective management by present technology or available management agents so that only extraordinary efforts, such as repeated chemical treatments at high dosage rates, can bring about effective management.”

Pictures of the plants are available on the website along with full descriptions of leaves, roots, flowers, and fruit as well as effective means of control. Want to know more about Water-lettuce, Water-hyacinth, or Hydrilla or how to identify other invasive aquatic plants, you'll find it all on the Florida DEP website.

## Meet Steve Gornak

Meet Steven Gornak, the new Florida Fish and Wildlife Conservation Commission person on Lake Istokpoga

Steven grew up in Northern Virginia where he enjoyed sports, especially playing football. His hobbies include building furniture, radio controlled planes, boats, and model rockets. He is a single parent and coaches his son's football and baseball teams. He loves to take him on hikes, bike rides, and teaches him about ecosystems and to respect natural areas.

Steven received a BS degree in Marine Biology with a minor in chemistry from Old Dominion University. He received a Masters degree in Oceanography with a concentration in fish management from the College of William and Mary school of marine science.

His work experience includes the design and conducting of research projects on Chesapeake Bay striped bass population including vegetation restoration and enhancement. He has worked for the FWC for 15 years including designing and conducting research projects used to manage largemouth bass, crappie, bluegill and redear sunfish (shell crackers). He also managed two large lake enhancement projects: one of the northwest marsh and another on Ritta Island at the southern end of Lake Okeechobee. These projects reestablished historical fish spawning and nursery grounds and created vast areas where wading birds could nest and feed. The ecosystem was also enhanced via the planting of native vegetation used by many of the fish and wildlife species found on the lake. He also sat on several task force groups designed to evaluate the effects of dredge projects on the lake's ecosystem, aquatic plant control procedures, and CERP proposals, and new water level regulation schedules.

When you see Steve on the lake or in the community, please make him welcome. He is willing to listen to your ideas and answer your questions.

### Istokpoga Grid Map

On pages 5 and 6 of this newsletter you will find a map of Lake Istokpoga with grid lines and GPS coordinates. We are providing this map for you to use in case you get stranded on the lake so that you can get assistance. Lake Istokpoga is a big lake and it is easy to get lost.

On the back of the map you will find phone numbers for the police and fish camps on the lake. If you do get stranded, call one of the contacts and let them know where you are by giving them the coordinates of your location.

If you are lost but not disabled, you can use your GPS unit to locate the fish camp you launched from by using their coordinates that are also listed on the map.

We will be providing a copy of the maps to each of the fish camps listed so they will have the exact same one you have. We suggest you laminate it and keep it in your boat.

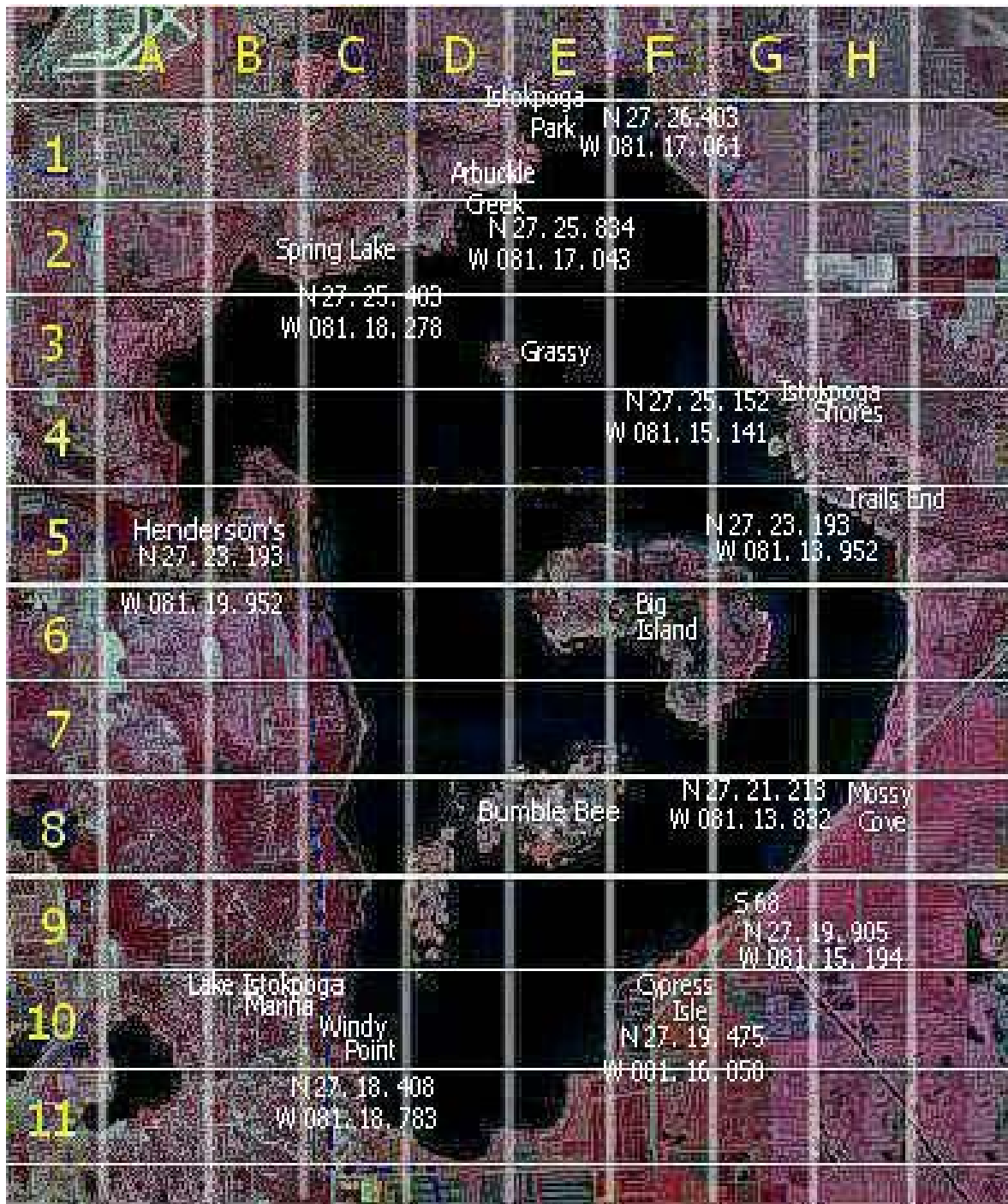

# What's Happening on Istokpoga

There are many projects and events happening on Lake Istokpoga at this time. I will try to bring you up to date on things that your board of directors are working on and other projects that are being performed by some of the state and local government agencies. Also I will try to give you some insight into events that have happened in the last few months.

## **A: Avon Park Correctional Facility Waste Water Treatment plant Modification Status**

The Friends of Istokpoga received a letter from the DEP in regard to the permitting of the waste water treatment plant at the Avon Park Correctional Facility. It is the intent of the DEP to monitor the output of total phosphorus that is being discharged into Arbuckle Creek and make sure that they adhere to the standard that is set. Our one problem is the state has not set the TMDL (total maximum daily loads for phosphorus) for Arbuckle Creek. This should be done this year.

## **B: Arbuckle Creek Monitoring of Water Quality**

Currently Paul Ritter from the SFWMD, is conducting a water quality assessment for the Arbuckle Creek watershed. He is trying to track down the areas in the watershed that contribute the most phosphorus loading of Arbuckle Creek and subsequently Lake Istokpoga. After he finds a problem he will work to eradicate the problem with better management practices, retention ponds and the like. This project is ongoing.

## **C: Aquatic Plant Management**

The weed management committee led by Ray Gaiefsky has set out to take pictures of weed control on the lake. They will take pictures of about a dozen locations that are

being sprayed by the different agencies on the lake. The pictures will be taken on a regular basis and they will always be taken at the same GPS location and same compass direction. We hope to do this for an extended period of time and show what effect the spraying is having.

## **D: Aquatic Plant Resistance to Herbicides.**

The herbicide that is used to control hydrilla on Lake Istokpoga can no longer be used. Fluridone, also known as Sonar, that has been very effective in controlling hydrilla can no longer be used, because the hydrilla on Istokpoga has become resistant to it. At this time we are fortunate that we have only a small amount of Hydrilla that is visible on the lake. There are some new herbicide products that are now being tested to see if they can do the job and control hydrilla. We are told that these new products are looking good but it is still too soon to pass final judgment on them. The hydrilla continues to expand and as of press time we still have no word on the new control for Hydrilla.

## **E: Canal Maintenance Dredging Evaluation**

Phase one of this project by South Florida Water Management District (SFWMD) has been completed. At this time we are waiting for SFWMD to evaluate the feasibility of this project and fund the actual work of cleaning the canals. We are told that this is at least two years off. We need this done completed before the any new Lake Regulation Schedule can be implemented.

## **F: Istokpoga Canal Project - US Army Corps of Engineers**

This is about an 18 month project to enhance the Istokpoga canal. There are three main features to this project. The one that is most important to Lake Istokpoga is the building of a new control gated levee (S-67) and demolition of the old existing one

(G-85). This control gate is about a ½ mile east of county road 621. It is old and it is leaking badly. We are glad to see this improvement. Also this project will build a new marina and boat ramp at US 98 and the Istokpoga canal. It will also dredge the Istokpoga canal from US 98 to where it intercepts the Kissimmee River.

## **G: Spring Lake Pumping Problem**

We all remember last summer when Spring Lake had its flooding problem. Well this problem was no fun for the residents of Spring Lake. Fortunately for them SFWMD and Highlands County were able to solve the problem by using emergency pumps to pump the flood waters directly into Lake Istokpoga. Unfortunately this event was harmful to Lake Istokpoga, because the pumped water had high nutrients and bacteria. This problem probably could have been avoided if Spring Lake could have pumped as permitted by SFWMD. But a judge's order voided this. Spring Lake currently has their engineers looking at all their options and they will continue to work until an acceptable solution is found. Be assured we will be watching for their solution.
